

- We are a 501(c)(6) nonprofit and nongovernmental organization

Funding Model:

Overview of NSC Research Center and StudentTracker System

NSC Research Center created in 2010

- 501(c)(3) non-profit organization
- Provide research and information for the benefit of the education community

StudentTracker for Colleges and Universities is the production system that institutions use to query enrollment and degree data from NSC. This service is in the midst of a major upgrade (more on that later).

The NSC Research Center supports StudentTracker by providing insights related to educational outcomes reporting, while also producing an array of national public reports and custom research services to clients

What has changed since the 2008 overhaul of the Higher Education Act?

- The Great Recession and austerity measures
- Millennials completing college and Post-Millennials (Gen Z) entering college
- Declining birth rates (recession, decline in teens giving birth)
- Increasing diversity in K-12 and on college campuses
- For-profit Sector: Litigation and Regulatory Action (last week's news)
- Traditional institutions' acceptance of MOOC's (edX)
- Programming Boot Camps, Stackable Credentials, Open Badges
- Data-driven decision making has become entrenched; Growing recognition that meaningful data are more valuable than voluminous data

The Accountability and Assessment Landscape in 2017

- The rapidly changing higher education landscape has led to a renewed focus on key questions around postsecondary access, equity, and learning outcomes and workforce outcomes.
- As a result, a serious national conversation on how to develop a meaningful national postsecondary data infrastructure is taking place, with the Institution for Higher Education Policy (IHEP) providing a forum for discussion.
- Eleven papers were released in 2016, including one authored by the Clearinghouse: <u>Envisioning the National Postsecondary Data</u> <u>Infrastructure in the 21st Century</u>.

NSC has evolved to be an integral part of the National Postsecondary Data Infrastructure

NSC is a **self-sustaining**, independent nonprofit organization, built as a voluntary data ecosystem that provides administrative services directly to colleges and universities, as well as data verification, exchange, research, compliance, and analytic services to entities in nearly all reaches of the education community.

NSC supports not only the efficient exchange of information among entities engaged in education and student services but also the **research uses of the data**, ranging from tracking and measuring student access and success outcomes to **benchmarking institutional performance**.

NSC as an Integral Part of the National Postsecondary Data Infrastructure

Four Pillars for Strengthening NSC's Role:

- Encourage and expand existing incentives, mechanisms and opportunities for voluntary transparency on the part of institutions. This means developing metrics and outcomes that offer value by benchmarking institutional improvement and student success.
- 2. Build stronger public-private partnerships among institutions, ED, and NSC to provide enhancements to public data such as the Integrated Postsecondary Education Data System (IPEDS) with minimal increase in institutional burden.
- 3. Develop a public access data facility that would bring PowerStatslike functionality to NSC data.
- Extend existing linkages between NSC data and local and state data systems.

NSC as an Integral Part of the National Postsecondary Data Infrastructure

- The institutions own their NSC data, are free to withhold it, and must consent to any public release of information using the data that identifies them by name.
- Unlike a governmental agency, NSC cannot enforce levels of participation or unilaterally disclose what is ultimately privately held data.
- To increase participation in a particular data element or initiative the NSC must demonstrate how participation adds value to institutions.
- This recognition of the institutions as key stakeholders is an essential aspect of NSC's role, as evidenced by the words of NSC Executive Research Director Doug Shapiro during the IHEP convening:

- 98% of college enrollments and graduations at degree-granting institutions are represented

How the Clearinghouse Can Help with Accreditation Outcomes Reporting

- The data template for the accreditation work is a holistic outcomes metric
- Current projects with WASC and SACS
- NSC would extract the entering cohorts from its own system to save institutions the burden of having to submit them.
- However, the intention is for institutions to have the ability, in the new STCU
 2.0, to be able to review and edit their cohorts.

How the Clearinghouse Can Help with IPEDS Outcome Measures

- It's possible that most institutions are already using the StudentTracker Cohort Query (or a different StudentTracker query) to satisfy their IPEDS OM reporting.
- However, we want to streamline the process as much as possible.
 IPEDS OM has four different cohorts to track:
 - 1. Full-time, first-time
 - 2. Part-time, first-time
 - 3. Full-time, non-first-time
 - 4. Part-time, non-first-time

(Along with the Pell sub-cohorts for each of these)

How the Clearinghouse Can Help with Veterans Outcome Measures

How do Veterans Outcome Measures differ from IPEDS OM?

According to this NCES website:

While some of the key ED outcome measures in the College Navigator are for first-time students, the VA and DOD outcome measures will be based on first-time beneficiaries.

So, in the GI Bill Comparison Tool, it appears that undergraduates and grad students, for example, would both be counted in the same graduation rate cohort if they both began using the Post-9/11 GI Bill in the same year.

NSC can play a role in making it possible to identify Veterans who are truly first-time-in-college if stakeholders agree that is the appropriate definition.


StudentTracker Data Use Cases

- Identify important enrollment trends and patterns
- Track concurrent enrollment of your students
- Determine cohort graduation rates
- Fulfill federal reporting requirements
- Where do our (non-matriculating) applicants to college?
- Where do our students attend graduate school?
- What do they study in graduate school? (e.g: how many of our theater grads go to med school?)
- Identify successful non-traditional student pathways to aid in student advising/counseling

StudentTracker 2.0: Institutional Reporting and Benchmarking Platform

- Clearinghouse has run a pilot for the last three years in which we have generated and delivered institution-level completions reports for free. These reports are based on the national dataset assembled for our public "Signature Report" on Degree Completions
- We have benefited from the feedback from institutions, and hope that institutions have found value in the pilot reports as well.
- The Reports will now be produced in the StudentTracker system so that their generation and delivery can be automated.
- Timing: Goal is to launch the new STCU reporting platform in Summer/Fall 2017.
- Will include institution-level reports on completions and persistence/retention, but other reports will likely be added in future.

StudentTracker 2.0: Analysis-Ready Detail File

- Institutions have frequently expressed feedback that the "long" format detail file is difficult to use, and requires a lot of data transformation before it can be used for analysis.
- 2. The "long" format file has one row per student per school per term which can add up to a lot of rows.
- 3. In response, a key part of the upgraded STCU service will be a "wide" format detail file. This version of the detail file will only have one row per student. However, the trade-off is that it will results in a lot of variables (wide file).
- 4. Guiding Principle for the analysis-ready detail file is flexibility, since many different institutions have many different reporting requirements, yet there are some common needs
- We are currently gathering feedback on the variables, use cases, data definitions, and layout
